Students must be baptized in the Catholic church and/or have received age appropriate sacraments.

Important Payment Information:

1. Check, money order, cashier's check (**Family ID must be included on all forms of payment**)
2. Tuition Loan for tuition only, **not fees**. All tuition loans, new or renewal of existing loans, must be applied for prior to 4/26/17 at www.tuition.gulfbank.com. If further assistance is needed, please contact the bookkeeper.
3. Late Fee- Any fee or tuition monies that are not paid by the due date will be subject to a \$50 late fee.
4. Beginning June 1, families who have not paid their tuition payment in full or obtained a bank loan will be charged the bank interest rate of 9% per month in addition to the above noted late fee.
5. If a student transfers during the year and a loan has been made, it will be reduced by the amount of the refund. There will be a bank charge of \$25 for canceling any loan. Prior to a refund, a letter notifying the Principal and bookkeeper must be received.
6. Please note our tuition refund policy for student transfers as reflected in the student handbook. If a student transfers during the school year, tuition paid in advance will be refunded according to the graduated tuition scale as follows:

May 15 – Sept. 1 50%

Nov. 2 – Nov. 15 35%

Sept. 2 – Oct. 1 45%

Nov. 16- Dec. 1 25%

Oct. 2 – Nov. 1 40%

Dec. 2- June 1 No Refund
